# Taylor's Island Preservation and Management Committee May 12, 2009 Minutes

NYSOPR&HP EPF/HP:

Co-Chair Hunt reported no word on when applicants will be notified.

# Bulkhead/Seawall repair/restoration funding possibilities: Community Land Preservation Fund (2% Committee):

As a result of Bernie Jacob's letter in the April 16<sup>th</sup> Shelter Island Reporter, Co-Chair Hunt attended the April 20<sup>th</sup> Community Land Preservation Fund meeting. She found the meeting time and location listed in the Town Calendar of the Town of Shelter Island's website. Co-Chair Hunt checked to read past minutes of the CLPF but found no listing for them on the Minutes page of the Town's website. Co-Chair Hunt asked Supervisor Dougherty why the CLPF minutes were not posted and he said they should be.

Co-Chair Hunt told the Committee she was interested in their response to Bernie Jacob's letter, as well as additional points she read from the Town Code. The CLPF members agreed it's a matter of interpretation and suggested Fred Thiele would have the answer. Co-Chair Hunt said she would contact Assemblyman Thiele and report back to the CLPF.

#### **Preserve America:**

Co-Chair Hunt spoke with Teresa Montant who suggested going to the Preserve America website. Co-Chair Hunt reported there are grants you can apply for.

# **Cell Tower Revenue-Capital Fund:**

With this fund collecting about \$4,000 per month, Co-Chair Hunt asked Supervisor Dougherty how much is in the Capital Fund. Supervisor Dougherty said to ask Town Attorney Laury Dowd.

# Taylor's Island 2009 Town Budget:

The Taylor's Island Preservation and Management Committee budget has a balance of \$27,800.

# Financial Business—April 30, 2009:

Co-Chair Hunt reported:

NY Class Account balance is \$80,181.87; Chase Business High Yield Savings Account balance is \$3,807.20. General Fund is \$2,000.

Co-Chair Hunt spoke with Kathy Sullivan regarding the Town's Taylor's Island folder. Kathy will follow-up with Town Attorney Laury Dowd.

# **Update on Website:**

Co-Chair Hunt reported a total of 7,976 visits.

# **Update on Work Accomplished at Taylor's Island and Future Plans:**

Co-Chair Surozenski spoke with an electrician about hooking up the generator and a mason about a concrete slab for the generator to sit on, in the spot where the old generator was located. Committee members spoke about the one spot where invasives continue to grow on Taylor's Island and the idea of a native species being introduced in that spot. Michael Laspia thought no native species could compete with this Japanese bamboo and suggested putting black plastic over it. Michael offered to have The Nature Conservancy take on the eradication of this invasive as a project.

# **Update on WMAC:**

Co-Chair Hunt attended the May 4<sup>th</sup> meeting and gave each member of the Council the attached letter. Co-Chair Hunt responded to Town Board Liaison Peter Reich's April 30, 2009 email regarding fill by bringing the Taylor's Island NYS DEC Permit file and made copies of pages WMAC Member Al Loreto asked for. Taylor's Island Committee Members Keith Clark and Michael Laspia said the spoils of the dredging project at the mouth of Coecles Harbor would be too wet and need a staging area to dry before using on Taylor's Island.

## **Update on NYS Economic Recovery and Reinvestment Cabinet:**

Co-Chair Hunt hasn't received additional email updates.

Co-Chair Hunt phoned Congressman Tim Bishop's Southampton office and spoke with Jane Finalborgo regarding Tim visiting Taylor's Island on Monday, May 18<sup>th</sup> either before or after the ribbon cutting ceremony on Shell Beach. Jane offered to check with Tim's scheduler, Lisa. Co-Chair Hunt received a call from Lisa saying Tim had something just before and needed to catch a return flight to Washington, DC right after.

Co-Chair Hunt's April 6<sup>th</sup> phone calls to Assemblyman Marc Alessi's Wading River office to speak with Nicole, Marc's scheduler, and the Albany office to speak with Susan as a follow-up to a February 6<sup>th</sup> email have not been returned. Supervisor Dougherty extended an offer to make those calls along with Co-Chair Hunt, who said she'll accept after one more try.

## **NYS DEC PEP:**

Co-Chair Hunt attended and presented Taylor's Island at the Thursday, April 23<sup>rd</sup> meeting at Town Hall with Laura Stephenson and Wayne Grothe of the Peconic Estuary Program. Wayne Grothe will present Taylor's Island to the PEP Natural Resources Subcommittee.
