Old Business:

Grant:

NYSOPR&HP EPF/HP:

No update.

Bulkhead/Seawall repair/restoration:

Co-Chair Hunt shared the two October 4, 2010 letters received from the Town Clerk's office, one letter designating the transfer of funds, the other letter authorizing and directing the Supervisor to credit the check received from the Taylor's Island Foundation for payment of the Stout Construction invoice for the work on Areas 3 and 4 of the NYS DEC permit. Grading and planting by Committee and Foundation members and other volunteers will continue for the next month or so.

Financial Business—September 30, 2010:

Co-Chair Hunt reported:

NY Class Account balance is \$80,435.57; Chase Business High Yield Savings Account balance is \$4,519.97.

Co-Chair Hunt asked Kathy Sullivan for information on the \$2,000 donation given to the Town of Shelter Island in December 2005 for Taylor's Island.

2011 Budget

Kathy Gooding reported on the Town Board Budget Hearing Meeting which included keeping the Taylor's Island Preservation and Management Committee 2011 budget figures the same as the 2010 budget figures. A new account heading for Cabin Repairs will be added rather than a change in an account heading. Co-Chair Hunt to follow-up with Kathy Sullivan on the creation of this new account.

Update on Work Accomplished on Taylor's Island and Future Plans:

Committee Members reviewed and updated a list of repairs and seasonal chores.

Friday Night Dialogue at the Shelter Island Library:

Co-Chair Hunt and Committee members discussed format, materials and information for this presentation to the Shelter Island community on Friday, November 12th from 7:00-9:00 PM.

Grant Consultant Jean O'Connell's visit to Town Hall:

Co-Chair Hunt met with Jean O'Connell on Wednesday afternoon, September 29th, and explored future green energy options for the Cabin. Our Committee is focused on the restoration of the Smith-Taylor Cabin and awaiting notification on our 2010 NYSOPR&HP/EPF Grant application.

Update on Website and facebook:

Co-Chair Hunt shared statistics which include: for the month of September the website had 454 visits with 1,743 page views; to date, Taylor's Island has 351 fans on facebook. Co-Chair Hunt read an email received from the website from Mr. Taylor's grand-nephew.

Keith Clark and Kathy Gooding reported on the docent tours they gave of the Smith-Taylor Cabin for Shelter Island residents.

Fundraising:

Two new fundraising possibilities, an appeal letter and an event at a North Fork venue, were briefly discussed.
